

## Transient Student Application

- Transient student status covers those who have obtained their undergraduate or graduate degrees from AUS and have returned to take extra course(s) at AUS.
- Transient students may enroll in any university course for which they have the necessary academic background and qualifications. Course registration is done through the Office of the Registrar. In courses with enrollment limits, priority is given to AUS students.
- Admission as a transient student is valid for one semester.
- Normally, a student can register as a transient student for no more than one academic year.
- Documents to attach to this application:
  1. a copy of your most recent valid passport and
  2. a copy of your most recent valid UAE national ID (make sure to photocopy both sides of the ID card)
- A non-refundable application fee of AED 350 is due at application time. This fee is exclusive of the UAE Value Added Tax (VAT). AUS reserves the right to charge and collect the applicable VAT from the student in line with the VAT laws and regulations as implemented in the UAE effective January 1, 2018.
- Students are expected to pay their tuition and fees or to make arrangements for deferred payment during the registration period.
