Awards:

Award		Faculty/LI	Description/Eligibility
1.	Excellence in Teaching	Faculty	This award recognizes a faculty member who has achieved both national and international status as a leading educator and has made significant contributions to improving teaching practice at AUS.
2.	Excellence in Research	Faculty	This award recognizes a faculty member who has made a substantial research contribution to their respective discipline, and has achieved national and/or international recognition for their research at AUS.
3.	Outstanding Interdisciplinary Research	Faculty Team	This team award recognizes interdisciplinary research accomplishments of a team of faculty members that has contributed significantly to the academia and the society at large.
4.	Excellence in Teaching	Laboratory Instructors	This award recognizes a lab instructor for their contributions in pedagogical innovations, educational technology development, laboratory experience improvement, educational software usage, lab and curriculum development, etc.
5.	Excellence in Service	Faculty/LI	This award recognizes a faculty member or lab instructor's service-related contributions within the university.
6.	Outstanding Community Outreach	Faculty/LI	This award recognizes a faculty member or lab instructor who has significantly contributed towards building community relationships and has had a long-term impact on AUS community through their outreach activities.
7.	Outstanding International Collaboration	Faculty	This award recognizes a faculty member who has significant international collaboration. Publications with international coauthors and joint projects with international partners are examples of international collaboration.
