

## The MSA Curriculum

To qualify for graduation with the MSA degree, students must successfully complete six core courses and four elective courses.

### **Required Core Courses**

ACC 610 Topics in Financial Accounting ACC 611 Auditing and Attestation ACC 612 Advanced Topics in Managerial and Cost Accounting ACC 614 Regulatory Environment in Accounting ACC 615 Enterprise Database Systems and Analytics ACC 616 Advanced Topics in Financial Reporting

## **Elective Courses**

MSA students must complete two accounting elective courses from the following:

ACC 620 Forensic Accounting and Fraud Examination

ACC 622 Internal Auditing

ACC 623 Financial Statement Reporting and Analysis

ACC 628 Fraudulent Financial Reporting

ACC 694 approved special topic ACC courses

Students must also complete two non-accounting elective courses from the following:

- one or two 600-level MBA courses (excluding MBA 613)
- one or two 600-level MSF courses

## **Admission Requirements**

For full admission to the MSA degree program at AUS, an applicant must:

- · have a relevant bachelor's degree with a minimum cumulative GPA of 3.00 from an independently accredited university recognized by the UAE Ministry of Higher Education and Scientific Research. Applicants with a bachelor's degree obtained outside the UAE must submit an equivalency of their degree from the UAE Ministry of Higher Education and Scientific Research.
- have attained a minimum Internet-Based TOEFL score of 80 or a minimum IELTS score of 6.5.
- submit a current vitae/resume.

Applicants who do not meet the full admission requirements might be eligible for conditional admission to the program and are encouraged to check our website for more details.

• The AUS MSA can help you become a licensed Certified Public Accountant (CPA).

AUS' MSA will help you meet the 150-hour education requirement for CPA certification, as well as prepare students for the CPA examination through our tailored curriculum. The CPA exam is currently offered in the UAE, meaning you can prepare for and take the exam right here in the UAE. We have a number of faculty members who are licensed CPAs and know what it takes to qualify and register as a CPA.  As a graduate student at AUS, you have the flexibility to choose between a part-time or full-time schedule, with classes offered at times suitable for those in the workforce.

The program offers a fast-track option for individuals without an accounting background or recent qualifications, allowing you to complete your degree more quickly.

 AUS offers competitive full and partial graduate assistantships for qualified students, along with additional graduate student employment opportunities.
